Since its official rollout in late 2023, Resident has been made available in all 13 provinces and territories across Canada, ensuring comprehensive coverage of the nation's diverse regions.

This wide-scale deployment was driven by the goal of creating a unified system that could handle the complexity of Canada's varied governance structures at federal, provincial, territorial, and municipal levels. Included in Resident today are:

- 1 country (Canada)
- 13 provinces and territories
- 3,483 municipalities
- 38 boroughs (Quebec only)

#### **Ministries**

- 26 federal ministries
- 237 provincial and territorial ministries/departments

## Agencies

- 177 federal agencies listed
- 1,926 provincial and territorial agencies listed

#### **Electoral Districts**

- 338 federal districts
- 772 provincial and territorial districts
- 4,329 municipal districts

#### **Elected Officials**

- 338 federal elected officials
- 772 provincial and territorial elected officials
- 22,000 municipal elected officials




## A Visual Representation

# Canada's very own 'LinkedIn for Democracy'



In the era of digital first branding and direct-to-voter engagement, it comes as no surprise that high-profile leaders are launching their own social media platforms.

Donald Trump's Truth Social brought this trend to the forefront in the United States, driven by a promise of "unfiltered" and "unbiased" conversation for his supporters.




